Baked goods · Icing with > 65% sugar · Dry baking mixes · Fresh uncut fruits, vegetables, herbs · Whole frozen fruits and vegetables · Intact salad greens · Certain cut produce and cut herbs · Nuts & Nut butters · Honey · Eggs · Poultry · Home canned fruit jams/jellies\* Reduced or no sugar fruit jams and jellies require a product assessment · Canned soda/pop based jellies · Canned high acid foods · Juice, cider · Candy and fudge · Chocolate dipped products not requiring refrigeration · Cultivated whole mushrooms · Whole fish and seafood · RTE Foods and beverages, 6 or < per year · RTE Foods and beverages (sold for immediate consumption by community groups for fundraising purposes) · Non specialized processed food sold 6 or < days/year · Homemade dried pasta · Vanilla extract · Spices · Loose leaf tea · Lard · Pepper Vinegars · Herb flavored/infused vinegars · Grain products · Fruit leathers · Sampling products

#### FOODS ALLOWED WITH PROPER LICENSING (POTENTIALLY HAZARDOUS FOODS AND BEVERAGES)
